Hello, Farmington Neighbors!

To quote Amanda Gorman, "The first bud of spring sings the other seeds into joining her uprising." The singing uprising of spring buds is evident throughout the neighborhood, and I look forward to the song continuing on through the season.

We had an unfortunate incident in our neighborhood back in February in which a vehicle chase entered our neighborhood and the chase ended in a shooting. Our Neighborhood Watch Captain, James, was able to speak to Police Chief Talbot about the incident and the FCA (Farmington Civic Association) provided footage from our security camera. None of those involved lived in or had any known connections to Farmington. HPD has stressed the most important thing we can do to keep crime low in our neighborhood is ensure our vehicles are locked, that no valuables are visible in parked vehicles, and that we don't leave cars running unattended and unlocked. We, fortunately, have had no similar further incidents.

The FCA has been hard at work planning for the upcoming year. We expect to do high school graduate recognitions, have a summer picnic, and continue to have insightful guest speakers at our general membership meetings. Our general membership meeting in February with Codes and Compliance was well-attended, and we hope to continue this trend.

#### General Membership Meeting with Codes Official

We had a well-attended general membership meeting on February 27th featuring special guest Kim Mikel from the Codes office. It was so well-attended we had to keep bringing in more chairs (thanks to Mayor Tuck for his assistance with that). Ms. Mikel reviewed codes that would apply to properties in our neighborhood. Below are highlights from her presentation:

- **1.** On properties of less than 5 acres, there is a limit of 2 motorhomes and recreational equipment (boats, trailers, etc) but only 1 of the 2 can be a motorhome.
- 2. Vehicles, motorhomes, and towed recreational vehicles on street frontage must be parked on an impervious surface that extends beneath the entirety of the vehicle and extends to the right of way (road). If the impervious surface is a loose material (e.g., gravel) it must be enclosed by a border.
- **3.** Those whose homes are on a corner lot have 2 street frontages, so the above requirement applies to the side with street frontage as well as the front of the house.
- **4.** The definition of inoperable vehicles includes tags out of date, expired inspection (more than 60 days), flat tires, or major components missing.
- **5.** There is now an ordinance that allows the city to restrict items not considered debris (trash, broken items, etc.) but that are stored outside and may be detrimental to the well-being of a community (otherwise known as clutter).
- 6. Grass can't exceed 8 inches in height.
- **7.** Overgrowth of bushes, etc. is considered unlawful if it could cause health and safety issues (obstructs view of the address, growing into the structure, obstructs access to escape and rescue opening points, etc.).
- 8. Residents are encouraged to communicate any concerns regarding codes violations via 311.
- **9.** Codes officials will need to be able to see the violation from the road or have owner permission to come onto the property. If they have permission from an owner of an adjoining property to access the adjoining property that would give a better vantage point than the road please include contact information in the 311 report.

In some instances, the Farmington subdivision covenants are stricter than the city code. I would encourage residents to review the covenants under the Community Information tab at our website, farmingtonva.com.
